- 5. Use of chalk, paint, or markers on sidewalks or walls is not permitted.
- 6. No confetti is to be used in park (damages pump in fountain).
- 7. Please keep music and noise at a reasonable level.
- 8. No animal displays or sales are permitted. All pets must be kept on a leash.

## Market Pavilion:

- 1. No alcohol use is permitted in the pavilion (unless state and local ABC permits have been obtained).
- 2. Please use receptacles available to dispose of trash.
- 3. Under no circumstances should anyone climb on the structure or hang anything from the structure. No alterations to the structure are permitted.
- 4. Use of chalk, paint, or markers on floor or the structure itself is not permitted.
- 5. Please keep music and noise at a reasonable level.
- 6. No vehicles are permitted to be parked under the pavilion.
- 7. No vehicles are permitted to be parked in the Adena Trail Park.
- 8. No animal displays or sales are permitted. All pets must be kept on a leash.

### Adena Trail Park:

- 4. Use of paint or markers on the trail is not permitted.
- 5. Please keep music and noise at a reasonable level.

- 7. The electrical devices placed on the poles are not available for use without prior coordination from City Hall.
- 8. No animal displays or sales are permitted. All pets must be kept on a leash.
