The City of Mount Sterling is extending an opportunity for small businesses to apply for a matching funds grant which may be used to revitalize the façade of the business front or to make capital improvements to the exterior of buildings. The intent of this program is to assist tenants and/or property owners to preserve and enhance existing buildings in the city. <u>Incomplete applications will not be considered</u>. Applicants are highly encouraged to submit thorough applications for consideration. Applications will be reviewed by a committee and awarded based on several factors. Completion of this application does not guarantee an award. All grants will be issued through a reimbursement and may not exceed \$1,000.00 in matching funds. Funds will be awarded beginning September 1, 2022. To be eligible to apply for this grant, an applicant must:

- 1. Occupy a building (brick and mortar) within the city limits of Mount Sterling.
- 2. Own the property or have a lease agreement with the property owner.
- 3. Must have a valid Business License and be current on all City taxes and fees and Occupational Taxes due to Montgomery County.
- 4. Be open and operating before July 22, 2022.
- 5. Be a business with less than \$500,000 in annual payroll.

## **ATTESTATION** I understand that:

- Grant monies are considered taxable income and the City of Mount Sterling is required by law to report it as such and send a 1099 to each awardee.
- Demand for this grant funding may exceed resources. Submission of an application does not guarantee an award. Incomplete applications will not be considered for an award.
- If awarded a grant, all monies will be received after expenses dated beginning August 25, 2022. Eligible expenditures for grant money are limited to payments made by the awarded business or property owner for supplies, materials, or labor related to the project. Two quotes from a certified contractor must be obtained (unless the work is cosmetic and does not require a contractor i.e. paint only. However, an estimate of cost of work must be submitted for consideration).
- A copy of W-9 and Schedule C Form (2021) is required. If this has not yet been filed, then the most recent tax year filed (2019 or 2020) may be accepted.
